



Company Policy: Supply Chain Policy:

Version 2.0, October 2021

This policy sets out the minimum standards that must be implemented across Supply Chain activities to ensure that Al Nawras Medi-Lab Supplies LLC realizes best value from its aggregated Supply Chain expenditure whilst controlling risk exposure for the benefit of its shareholders and customers. Supply Chain activities are carried out in accordance with this policy, the supporting mandatory practices, and relevant operating procedures in each business area, which together provide a framework for all Supply Chain activities across the company.

Policy Standards:

Each Business Unit is responsible for the effective deployment of the Supply Chain framework in their area.

Key minimum requirements are:

1. All Supply Chain and purchasing activities must be for legitimate business requirements and authorized in line with our company's Financial Authority Limits and Commitment Authority Limits.
2. Supply Chain activities are carried out in accordance with the relevant Business Unit's processes and procedures.
3. Use of retrospective suppliers and purchase orders is not permitted.
4. Each BU has processes in place to ensure appropriate engagement of Supply Chain for the sourcing, selection, contracting and purchasing activities.
5. All Supply Chain and purchasing activities comply with relevant legislation and regulation.
6. We maintain our company standards for Health & Safety, Ethics, Sustainability, Diversity & Inclusion and Environmental protection.

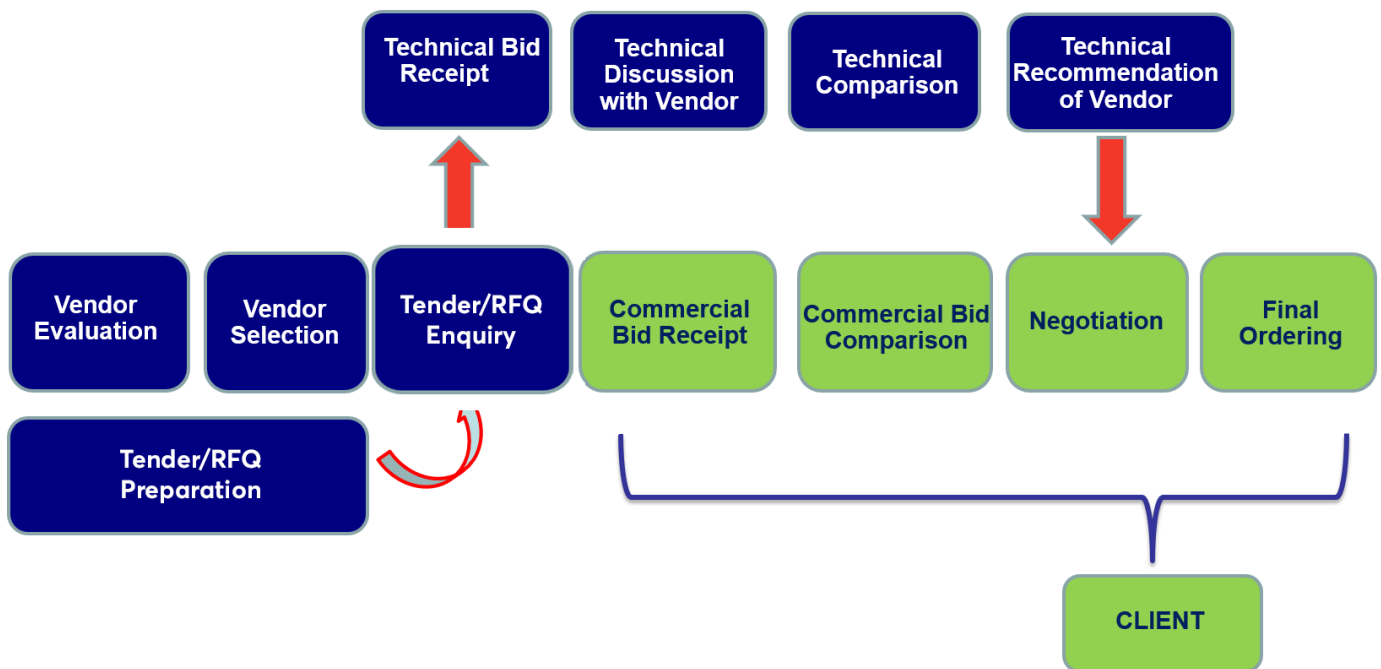


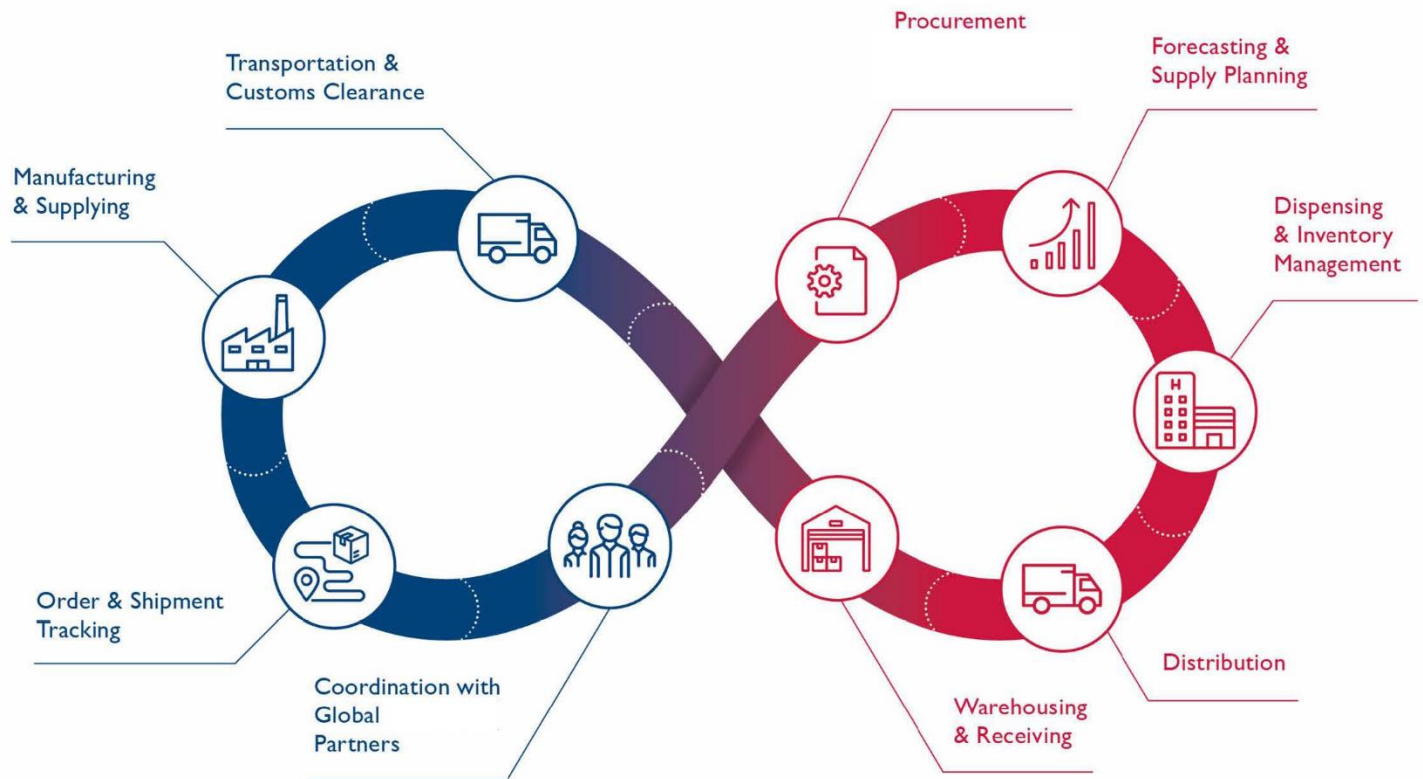
